

Events Information and Terms & Conditions

Birthday celebrations, corporate meetings, anniversaries; whatever the occasion, The Mule Room offers a perfect adaptable space, great local drinks and a dedicated events manager to ensure the smooth running of any event.

Drinks Request: You are able to choose your favourite Lord's Brewing Co beer to have on at your party. You can have an extra hand pump on for £60+vat which is returnable if we sell out of beer. Any other requests please speak to us and we will do our best to accommodate them.

Catering: We do not provide catering but we do have a full range of food vendors which we have a relationship with. We can put you in touch with them if requested. If you provide your own catering they must adhere to the T&C's for external caterers.

Music: We know quite a few good bands, DJs and musicians we can put you in touch with. If you are providing a band or DJ they can use our PA but at a cost of £40 +VAT. We can also pack our kit down if they have their own PA system. We can set out the space with room for a dance floor if required with disco lights.

ROOM HIRE TERMS & CONDITIONS

Interested in hiring our venue? Here are some things to consider.

Payment: We will invoice you for the total price of your venue package (less any deposit paid) approximately 28 days before the scheduled date of your event. You must pay our invoice in full no later than 14 working days from the date of invoice.

Your Responsibilities:

- No nuts may be brought into the building under any circumstances.
- No glitter or table confetti is to be used under any circumstances. Biodegradable confetti is permitted outside.
- No naked flames inside the building, this includes candles on cakes and sparklers.
 Also, no smoking in the building. This includes vaping.
- All decorations and food must be removed at the end of the event. There are strictly no exceptions to this rule for food. However, if you want to clear down the decorations on the following day there will be an additional charge. We will arrange for a staff member to be there if the brewery is not open.
- · If we are providing catering you must confirm final catering numbers no later than 28 days before your event so we are able to raise a final invoice. Subsequent increases in numbers will be invoiced separately. Please note, no refunds will be given for any decrease in the number of attendees. If the actual number of guests in attendance falls beneath the minimum number set out in our quotation, we will still charge you for the original number.
- · Unless we agree otherwise, only food and drinks supplied by us may be consumed at your event. Should you wish to provide your own beverages, our corkage charges will apply.



- · You must comply with, and to the best of your ability to ensure that your guests comply with, all of our reasonable instructions as to intended to ensure the safety of people, premises and property.
- We are an over 18 venue. If you wish to bring under 18 year olds you must get prior permission from the brewery owner John Slumbers. He can be contacted on 07825837713. Once guests have arrived, children under 18 must remain inside the brewery unless accompanied by a parent/guardian. Children under 14 years old are not permitted to remain at the venue later than 8.00pm unless a prior arrangement has been made at the time of booking. Children are not permitted to run around the brewery or climb the furniture and under no circumstances enter any area of the brewery production areas.
- · You must provide your guests with such information regarding arrangements to be followed at the venue for your party (for example, in relation to car parking, how to get to the venue the storage, booking a taxi to leave prior to the event).
- Any damage caused to the venue, its equipment, contents or fittings will result in an invoice sent directly to you immediately after the event.

CATERING TERMS & CONDITIONS

Interested in hiring our venue? Here are some things to consider.

Cooking Outside: We can provide electric to the car park although it is not rated past 13 amps. Inside we have an area you can trade from which has multiple sockets. It can be very cold and windy where we are so I advise you park your vehicle carefully to shelter you from the elements. The car park is steep but there is a level area at the bottom which will be made available for you.

Cooking Inside: If you are cooking inside please be aware we have an active fire detection system in place. If the alarm goes off, we have no way of turning it off. So please do not create any smoke or we will have to shut. We have a hand washing sink and a washing up sink that you can use. *Please do not use our glass washer for cleaning plates, cutlery or the like. We have provided lighting for your area and multiple sockets.

Waste: You must take all of your waste with you absolutely no food waste must be left under any circumstances. If you want to use our commercial waste disposal there is a charge of £15.

Insurance & Food Certification:

Additional Points:

- · We reserve the right to intervene in any activity which we reasonably believe is likely to cause damage to the interior or exterior of the venue or jeopardise the safety of guests or staff.
- We will not tolerate any abusive behaviour by guests to any other guests or member of staff.
- We reserve the right to remove any persons acting inappropriately from the event.
